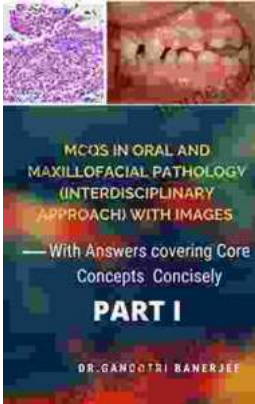
Image alt text: A graphic from the GAO report showing the need for a comprehensive policy review and an improved oversight strategy.

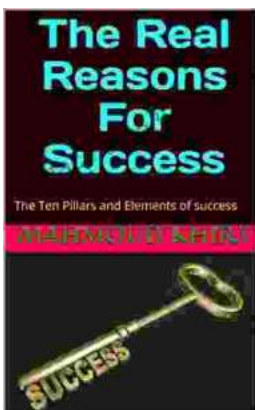
